

Exhibit “A” – Field Maintenance Agreement

The following outlines maintenance expectations for the use of any or all three Borough-owned fields:

1. Legion Field – Large South Ball Field
2. Legion Field – Small North Ball Field
3. Softball Field

Myerstown Borough (“Borough”) shall be responsible for the following:

1. The Borough shall maintain turf areas on all fields to include mowing, weed control, fertilizing, herbicide spraying, and any other treatment deemed necessary by the Borough.
Note: It is unlawful for anyone other than a licensed Borough employee to apply any type of weed control, fertilizer, or herbicide spray.
2. The Borough shall perform all pre-season turf maintenance to the Borough’s satisfaction and shall provide materials to be used in leveling or backfilling low areas when deemed necessary by the Borough.
3. The Borough shall provide an outdoor batting cage for the baseball fields, to be constructed before the beginning of the season, and taken down after the season.
4. The Borough shall drag the infield skin of the baseball/softball fields on the morning of all game days.
5. The Borough shall maintain all bleachers/benches in a safe and secure condition.
6. The Borough shall provide receptacles for trash disposal and shall be responsible for emptying them.

The Group or Organization (“Applicant”) using the fields shall be responsible for the following:

1. The Applicant shall be responsible for line striping or markings required for the field use.
2. The Applicant shall be responsible for policing of all litter on the fields to include playing areas, dugouts, fences, backstops, bleachers, concession stands and adjacent grounds. All litter shall be placed in trash receptacles for pick up at the designated site. All recyclables must be recycled per Borough Ordinance.
Note: Litter left in any of the areas identified above will result in a \$100 fine per occurrence to cover labor costs for cleaning. Nonpayment of fine will result in revocation of field access.
3. The Applicant shall be responsible for removing all equipment (i.e. bases, drags, ladders, etc.) from the field after use and securing equipment in the storage shed.
4. The Applicant shall be responsible for removing all scoreboard numbers from the scoreboard after use and securing them in the storage shed.

The Group or Organization (“Applicant”) understands and agrees to the following:

1. The Applicant shall be prohibited from performing any maintenance to any turf, field areas, or structures without written permission from the Borough.
2. The Applicant shall be prohibited from making any improvements to any Borough facilities without written permission from the Borough.
3. Any request for improvements to facilities for the following year must be submitted to the Borough no later than the September meeting of Borough Council.
4. The Borough is not responsible for any items that are lost or stolen from the storage facility.
5. The Applicant shall follow all applicable Borough Ordinances and Facility Use Rules and Regulations.
